### Nominations

Nominations open at midday on Tuesday, 19 March 2019. All nominations must **reach the Electoral Commission of Queensland no later than midday on Tuesday, 16 April 2019**. A nomination form is printed with this notice. Additional forms can be obtained either from the Union or the Electoral Commission of Queensland. To be eligible to nominate, candidates must be a financial member of the Union thirty (30) days prior to the opening of nominations and not be a Professional Engineer, Pharmacist or a Professional Scientist member.

Nominations may be received by hand delivery, post, fax or email and must include the signature of the nominee.

Nominees should ensure that their nomination is received by the Commission and can be clearly read.

### Ballot

If necessary, the Commission will undertake a secret postal ballot of eligible members commencing Friday, 10 May 2019 and closing on Friday, 31 May 2019. To be eligible to vote, members must be a financial member thirty (30) days before the date nominations open.

The position is to be elected by eligible members of the Union. Members should advise the Union of any change relating to their membership details.

Ballots are decided by a first-past-the-post system of voting.
