Election Notice

The Queensland Industrial Registrar has issued Decisions, pursuant to the *Industrial Relations Act 2016*, that the Electoral Commission of Queensland conduct an election for positions of office within the Queensland Teachers Union of Employees.

Candidate Notes

Candidates for election must be financial members of the Union at the close of nominations.

All nominations must be in writing and signed by the nominee and at least two (2) financial members of the Union, provided that:

Nominees for **Branch Delegate to an Area Council** or **State Council Representative of a Branch** must be a member of the respective branch and be nominated by at least two (2) financial members of the relevant branch.

Nominees for **State Council Representative of an Area Council** must be a Branch Delegate to the relevant Area Council or a duly nominated candidate for election as a Branch Delegate to the relevant Area Council.

Nominees for **Area Council Officer** positions must be must be a Branch Delegate, or duly nominated candidate for election as Branch Delegate, to the relevant Area Council and be nominated by at least two (2) financial members who are Branch Delegates to the relevant Area Council.

Nominees for **Trustee** must be a Branch or Area Council Council Representative or be a duly nominated candidate for election as a Branch or Area Council Council Representative.

Candidates who wish to withdraw their nomination may do so not more than five (5) clear days after the close of nominations. Prospective candidates and their nominators should verify their financial status and other qualifications required by the Union (refer to Union Rules 6.4 & 6.5).

Nominations close at midday on Tuesday, 14 May 2019

Nominations open on **Tuesday, 23 April 2019**, and must be in writing, comply with the registered rules of the Union and be received by the Electoral Commission of Queensland (the Commission) **no later than midday on Tuesday, 14 May 2019**.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominee and nominators. Please ensure that your nomination can be clearly read.

A nomination form for this election is printed with this Journal. Forms are also available from the Union and the Commission's website; www.ecq.qld.gov.au.

Ballots

Should a ballot be necessary to elect the successful candidate/s for positions of State Council Representative of a Branch or Branch Delegate to an Area Council the Commission will conduct a secret postal ballot. These ballots, if required, will **open on Friday, 7 June 2019** and **close at midday on Friday, 28 June 2019**.

Should a ballot be necessary to elect the successful candidate/s for the positions of Trustee, State Council Representative of an Area Council or Area Council Officer positions the Commission will conduct a secret ballot of Branch Delegates at the Council meeting to be held after nominations close.

To be eligible to vote in this election, members must be financial for 30 days before the opening of nominations.

The voting system to be used is optional preferential voting.
