# **Background**

On the 8 April 2015, the Honourable Deputy Premier, Minister for Transport, Minister for Infrastructure, Local Government and Planning and Minister for Trade Jackie Trad MP, referred Councils' application for consideration to be given to the realignment of the common boundary between the Brisbane City Council and Moreton Bay Regional Council.

The application proposes a change to the common boundary between the local governments and involves the following lots currently located in Moreton Bay Regional Council —

- Part of Lot 1 on Plan MPH20165; and
- Part of Lot 220 on Plan SL8499.

Further the reference refers to extension of the Moreton Bay Regional Council seaward boundary in Hays Inlet to include the Ted Smout Bridge.

It is proposed that—

- Part of Lot 1 on Plan MPH20165, Enoggera Reservoir; and
- Part of Lot 220 on Plan SL8499, Camp Mountain

be transferred to the Brisbane City Council.

It is also proposed that the Moreton Bay Regional Council seaward boundary in Hays Inlet be extended to include the Ted Smout Bridge which is currently unallocated to a Local Government Area.

The Change Commission in this case is comprised of the Electoral Commissioner Mr Walter van der Merwe and a Casual Commissioner Mr Gregory Rowe, in accordance with Section 22 of the *Local Government Act* 2009 (the Act). The Change Commission is responsible for assessing whether a proposed local government change is in the public interest. In doing so, the Change Commission must consider—

- whether the proposed local government change is consistent with the Act; and
- the views of the Minister about the proposed local government change; and
- any other matters prescribed under a regulation.

Section 19(3) of the Act provides that the Change Commission may conduct its assessment in any way that it considers appropriate including, for example—

- ask for submissions from any local government that would be affected by the proposed local government change; and
- hold a public hearing to ask the public for its views about the proposed local government change.

The Change Commission determined that a public hearing was unnecessary on this occasion.

# **Submissions**

The Minister referred this matter to the Change Commission based on a submission received from the Moreton Bay Regional Council. The Minister referred these matters without expressing a view for or against the proposal (see Appendix A). The Council's submissions are included in Appendix B.

The Minister's referral also included correspondence from the Brisbane City Council supporting the Moreton Bay Regional Council's proposal to move the referred lots into the one Council area.

Both Council's expressed agreement that the two Lots should be moved into Brisbane City Council.

The private owner of Lot 1 on Plan MPH20165 was unabled to be contacted by the Change Commission. The area of land involved is approximately 4,412 square metres. The land is undeveloped. Lot 220 on Plan SL8499 is a reserve for scenic purposes.

The Change Commission determined that it was unnecessary to call for further submissions on this occasion, as both Council's are in support of the transfer.

Moreton Bay Regional Council's submission also included a proposal that its seaward boundary in Hays Inlet be extended to include the Ted Smout Bridge which is currently unallocated to a Local Government Area.

Both these anomalies were submitted to the Minster and the Change Commission based upon advice from the then Department of Environment and Resource Management.

# **Findings**

After an assessment of the material submitted and having taken into account all considerations specified in the Act, it is recommended that firstly —

- Part of Lot 1 on Plan MPH20165; and
- Part of Lot 220 on Plan SL8499

be moved from Moreton Bay Regional Council to Brisbane City Council. The lots are located in the localities of Enoggera Reservoir and Camp Mountain respectively.

Secondly, it is recommended that the Moreton Bay Regional Council seaward boundary in Hays Inlet be extended to include the Ted Smout Bridge.

# **Reasons for Findings**

The proposed boundary change is assessed as being consistent with the *Local Government Act 2009*.

The Change Commision supports the Council's submissions to move parts of the two lots from Moreton Bay Regional Council to Brisbane City Council. This transfer is in the interests of the landowners, the Councils and also for essential services, as it will result in the entirety of the lots being included in the same locality and Council area. In doing so, this will help reduce the confusion caused when local government boundaries bisect lots.

The movement of the Moreton Bay Regional Council's seaward boundary in Hays Inlet to include the Ted Smout Bridge is in the interest of the public to ensure that the bridge is included in the appropriate local government area.

The Change Commission's support for the referred changes to address both of the lots and seaward boundary anomalies, have been made in the public interest.

# **Implementation**

The Governor in Council may implement the Change Commission's recommendation under a regulation.

The regulation may provide for anything that is necessary or convenient to facilitate the implementation of the local government change.

# Local Government Boundary Anomalies - Moreton Bay Regional Council

I wish to advise that two anomalies have been identified along the Moreton Bay Region boundaries.

These anomalies are as follows:

- The boundary across Hayes Inlet the boundary is currently east of the old Houghton Highway Bridge, however the Ted Smout Bridge is not located in any local government area.
- CHQ024459/668 Lot 1 on MPH20165 and Lot 220 on SL8499 City of Brisbane (Locality of Enoggera Reservoir) and Moreton Bay Regional Council (Locality of Camp Mountain) – Lot 220 on SL8499 is a Reserve for Sce4nic Purposes and Lot 1 on MPH20165 is a privately owned block of land.

Plans and Maps showing these locations are attached.

In relation to Anomaly No. 1 (Hayes Inlet), there are no adjoining local government areas involved.

In relation to **Anomaly No. 2 (Enoggera Reservoir and Camp Mountain)**, approval has been obtained from Brisbane City Council to proceed with the amendment.

A copy of Minute Pages where both Anomaly No. 1 and No. 2 were considered by Council are attached, along with Brisbane City Council's response in relation to Anomaly No. 2.

I further wish to advise that with regard to the Moreton Bay Region boundaries, there are also locations where the high water mark has changed and this area should be identified and amended to incorporate the current high water mark. There are no other adjoining local government areas involved.

It would be appreciated if you could arrange for these anomalies to be rectified.

#### **Executive Summary**

This report concerns the amendment to the Local Government boundary between Brisbane City Council and Moreton Bay Regional Council and seeks Council's approval to seek an assessment by the Change Commission.

#### Background

Advice has been received from the Department of Environment and Resource Management that they have identified an anomaly pertaining to the Moreton Bay Regional Council Local Government Boundaries. This anomaly has a direct effect on maintaining correct suburb/locality boundaries, which are essential for the delivery of business and emergency services. The anomalies occur when a local government boundary bisects property lots, effectively dividing the parcel of land between two different Council areas. As a consequence, these properties are sometimes split into two different suburbs or localities, which cause further confusion for landowners, Councils and essential services.

# 2. Explanation of Item

The anomaly identified along the Moreton Bay Regional Council boundary is delineated on the plan appearing in the Attachments and is as follows:

 CHQ024459/668 – Lot 1 on MPH20165 and Lot 220 on SL8499 – City of Brisbane (Locality of Enoggera Reservoir) and Moreton Bay Regional Council (Locality of Camp Mountain).

Lot 220 on SL8499 is a Reserve for Scenic Purposes and Lot 1 on MPH20165 is a privately owned block of land.

The Department of Local Government has advised that local Councils involved with boundary anomalies, such as the above, should seek an assessment from the Change Commission under the Local Government Act 2009 to assess whether the change should be made.

# **Executive Summary**

This report concerns amendments to the Local Government boundaries of Moreton Bay Regional Council and seeks Council's approval to seek an assessment of the amendments by the Change Commission.

#### Background 1.

Advice has been received from the Department of Environment and Resource Management that they have identified two anomalies pertaining to the Moreton Bay Regional Council Local Government Boundaries. These anomalies have a direct effect on maintaining correct external and suburb/locality boundaries, which are essential for the delivery of business and emergency services.

These anomalies are as follows:

- The boundary across Hayes Inlet.
- A piece of land between Moreton Bay Regional Council and Brisbane City Council at the end of Ferny Way, Ferny Hills.

These anomalies are delineated on the satellite pictures appearing in the Attachments.

#### 2. **Explanation of Item**

#### 1. The Boundary across Hayes Inlet

The boundary across Hayes Inlet currently is east of the old Houghton Highway Bridge, however the newly constructed Ted Smout Bridge is not located in any local government area.

#### 2. Piece of land at end of Ferny Way, Ferny Hills

The Kedron Brook has changed its course over many years resulting in this piece of land not being included in either of the local government areas of Brisbane City Council and Moreton Bay Regional Council.

The Department of Local Government has advised that local Councils involved with boundary anomalies, such as the above, should seek an assessment from the Change Commission under the Local Government Act 2009 to assess whether the changes should be made.

Re: Local Government Boundary Anomaly off Mount Nebo Road, Locality of Camp Mountain

I refer to your letters dated 7 April 2011 and 1 May 2013, in which you requested Brisbane City Council's (Council) advice in relation to the above boundary anomaly. In your correspondence you supported amendment of the shared Local Government boundary to follow the northern alignment of Lot 1 MPH20165 and Lot 220 SL8499 (see attached map, CHQ 022459/668). This action would fully include both allotments into the Brisbane City Council area.

Following meetings between Council and Moreton Bay Regional Council (MBRC) officers and further internal consideration, Council agrees with your assessment. Complete inclusion of the properties within one LGA would:

- assist delivery of essential and emergency services by reducing confusion with addresses;
- facilitate management of Reserve 2841 by allowing consistent application of policy and communication for water catchment management, control of fire, weeds and feral animals;
- · simplify the approval process for both properties, with only one set of Council requirements; and
- comply with the City of Brisbane Regulation 2012, which stipulates that the external boundaries of Brisbane 'do not dissect properties' (7(1)(d)(iii) of Part 2).

In light of the above and as offered in your original letter dated 7 April 2011, please take action to request the Change Commissioner to consult with the affected owners and assess the proposed change to the boundary as recommended (i.e. following the northern alignment of Lot 1 MPH20165 and Lot 220 SL8499 as shown on attached map CHQ 022459/668).






# Overview Map Brisbane City Council and Moreton Bay Regional Council
