## Background

On the 8 April 2015, the Honourable Deputy Premier, Minister for Transport, Minister for Infrastructure, Local Government and Planning and Minister for Trade Jackie Trad MP, referred Councils' application for consideration to be given to the realignment of the common boundary between the Goondiwindi Regional Council and Western Downs Regional Council.

The application proposes a change to the common boundary between the local governments and involves the following lots currently located in Western Downs Regional Council —

- Part of Lot 8 on Crown Plan CVN344; and
- Part of Lot 1 on Survey Plan SP254479

It is proposed that—

- Part of Lot 8 on CVN344, Flinton; and
- Part of Lot 1 on SP254479, Southwood

be transferred to the Goondiwindi Regional Council.

The Change Commission in this case is comprised of the Electoral Commissioner Mr Walter van der Merwe and a Casual Commissioner Mr Gregory Rowe, in accordance with Section 22 of the *Local Government Act 2009* (the Act). The Change Commission is responsible for assessing whether a proposed local government change is in the public interest. In doing so, the Change Commission must consider—

- whether the proposed local government change is consistent with the Act; and
- the views of the Minister about the proposed local government change; and
- any other matters prescribed under a regulation.

Section 19(3) of the Act provides that the Change Commission may conduct its assessment in any way that it considers appropriate including, for example—

- ask for submissions from any local government that would be affected by the proposed local government change; and
- hold a public hearing to ask the public for its views about the proposed local government change.

The Change Commission determined that a public hearing was unnecessary on this occasion.

## Submissions

The Minister referred this matter to the Change Commission based on a submission received from the Goondiwindi Regional Council. The Minister referred these matters without expressing a view for or against the proposal (see Appendix A). The Council's submissions are included in Appendix B.

The Minister's referral also included correspondence from the Western Downs Regional Council supporting the Goondiwindi Regional Council's proposal to move the referred lots into the one Council area.

Both Council's expressed agreement that the two Lots should be moved into Goondiwindi Regional Council.

The private owner of Lot 8 on Plan CVN344 was unabled to be contacted by both the Council and the Change Commission. The owner of Lot 1 on SP254479 was agreeable to the proposed move of their lot to Goondiwindi Regional Council (see Appendix B).

The Change Commission determined that it was unnecessary to call for further submissions on this occasion, as both the Council's and one land owner were in support of the transfer.

These anomalies were submitted to the Minster and the Change Commission based upon advice from the then Department of Natural Resources and Mines.

## Findings

After an assessment of the material submitted and having taken into account all considerations specified in the Act, it is recommended that—

- Part of Lot 8 on Crown Plan CVN344; and
- Part of Lot 1 on Survey Plan SP254479

be moved from Western Downs Regional Council to Goondiwindi Regional Council. The lots are located in the localities of Flinton and Southwood respectively.

## **Reasons for Findings**

The proposed boundary change is assessed as being consistent with the *Local Government Act 2009*.

The Change Commision supports the land owner and the Council's submissions to move parts of the two lots from Western Downs Regional Council to Goondiwindi Regional Council. This transfer is in the interests of the landowners, the Councils and also for essential services, as it will result in the entirety of the lots being included in the same locality and Council area. In doing so, this will help reduce the confusion caused when local government boundaries bisect lots.

The Change Commission's support for the referred changes to both of the lots has been made in the public interest.

### Implementation

The Governor in Council may implement the Change Commission's recommendation under a regulation.

The regulation may provide for anything that is necessary or convenient to facilitate the implementation of the local government change.

### RE: REQUEST TO REVIEW THE LOCAL GOVERNMENT BOUNDARY BETWEEN GOONDIWINDI REGIONAL COUNCIL AND BALONNE SHIRE COUNCIL

I refer to the above and advise that in recent months, Council has given consideration to correspondence received from the Department of Natural Resources and Mines that identified 'anomalies' (that is, whole lots dissected by local government boundaries) in the local government boundary between Goondiwindi Regional Council and Balonne Shire Council, Western Downs and Southern Downs Regional Councils.

As a result of Councils consideration of DNRM's correspondence, Council wrote to the affected owners seeking their comments and requesting that owners consider which local government that area would be most suitable. Of the replies received, Council noted the property owners comments and requests and then considered the merits of each identified anomaly against the following criteria:

- Identifying the property owners' community of interest and incorporating their land holding into the respective government
- Incorporating the entirety of the rate assessment into one local government area generally following where the majority of assessment presently resides; and
- The most appropriate alignment for the boundary to prevent alienation of other parcels / properties within one property holding / rate assessment.

Council sees significant merit in resolving the anomaly created by Goondiwindi Regional Council and Western Downs Regional Council local government boundary dissecting Lot 1 on Plan SP254479. Council has resolved at its July 2014 meeting that we request you to refer to Lot 1 on Plan SP254479 to the Local Government Change Commission with Council's recommendation that this Lot be wholly incorporated into Goondiwindi Regional Council, following owners consent.

Conversely, Council sees no merit in initiating a review of its boundary in response to the other anomalies identified by the Department of Natural Resources and Mines.

Council notes that our neighbouring local governments may also be making requests to amend our Council boundaries. In referring Council's request (above) to the Local Government Change Commission, Council would greatly appreciate you directing the Commission to consult with Goondiwindi Regional Council prior to finalising any assessment on proposed boundary change initiated by adjoining local government.

Would you please contact Mr Jason Quinnell should you require any further information in relation to this matter.




