

Application to register a group of candidates

The Local Government Electoral Act 2011 allows candidates to form a group to contest an election.

Groups can only have one mayoral candidate, and can only contest one local government area. Candidates cannot be a part of a group if they are a member of another group, or if the candidate is endorsed by a registered political party. Applications which do not meet these requirements cannot be accepted.

Complete this form to register a group of candidates. This form can also be completed online through the Self Service Portal, available at www.ecq.qld.gov.au.

Unless otherwise indicated, all information in this form will be published for public inspection on the ECQ's website.

Lodgement timeframe

Groups can register at any time up to the day before polling day for an election. Candidates must not conduct group campaign activities until the group is registered.

Applications which are received after the close of nominations for an election will not be reflected on the ballot paper for the election.
