Candidate Notes

Candidates for election must be financial members of the Union at the close of nominations. All nominations must be in writing and signed by the nominee. Nomination forms must also be signed by at least two (2) financial members of the Union, provided that:

Nominees for **Member of Executive** must be a Branch or Area Council Representative or be a duly nominated candidate for election as a Branch or Area Council Council Representative.

Nominees for **Branch Delegates to Area Council and State Council Representative of a Branch** must be a member of the relevant branch and signed by at least two (2) financial members of the relevant branch.

Candidates who wish to withdraw their nomination may do so not more than five (5) clear days after the close of nominations. Prospective candidates and their nominators should verify their financial status and other qualifications required by the Union (refer to Union Rules 6.4 & 6.5).

Nominations close at midday on Friday, 6 September 2019

Nominations open at midday on **Friday, 16 August 2019**, and must be in writing, comply with the registered rules of the Union and **reach the Electoral Commission of Queensland (ECQ) no later than midday on Friday, 6 September 2019**.

A nomination form for this election is printed with this Journal. Forms are also available from the Union and the ECQ's office or website; www.ecq.qld.gov.au.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominees and nominators. Please ensure that your nomination can be clearly read.

Ballots

Should a ballot be necessary to elect a **Branch Delegate to Area Council** or **State Council Representative of a Branch** the Commission will conduct a secret postal ballot of financial members of the Union in the respective Branch. Ballots, if required, will open on **Wednesday, 2 October 2019** and close at **midday on Thursday, 24 October 2019**.

Should a ballot be necessary to elect the successful candidate/s for a position of **Member of Executive** the ECQ will conduct a secret ballot of Branch Delegates at the Council or Area meeting to be held after nominations close.
