## Nominations

### Nominations close midday on Wednesday, 22 July 2020

Nominations open at midday on Wednesday, 8 July 2020. All nominations must be in writing and reach the Electoral Commission of Queensland (ECQ) no later than midday on Wednesday, 22 July 2020.

Only persons who were financial members of the Association on the date four (4) weeks prior to the closing time for nominations, shall be entitled to nominate or be nominated for office.

All nominations must be signed by the candidate and by two financial members belonging to the TAB Regional Zone to which the nominations relates. A Council Member shall only be elected from a Regional Zone if their Agency is geographically located in such a Zone. Candidates and their nominators should verify their financial status and other qualifications required by the Organisation's rules before lodging a nomination form with the ECQ.

Nominations may be received by hand delivery, post, fax or email. Nominees should ensure that their nomination can be clearly read. Additional forms are available from the Union, the office of the ECQ or the ECQ's website; [www.ecq.qld.gov.au](http://www.ecq.qld.gov.au)

## Ballot

If necessary, a postal ballot will open on Tuesday, 4 August 2020 and close at 5pm on Tuesday, 18 August 2020. Ballot material will be posted to the members address shown in the Associations records, whose membership relates to that TAB Regional Zone.

Only members who were financial members of the Association 30 days before the opening time for nominations may vote in the election. Voting is by a First-Past-the-Post method.
