The *Local Government Electoral Act 2011* allows candidates to form a group to contest an election. Groups must be registered before candidates can engage in group campaign activities. This form should be completed to apply to the ECQ to register a group, and must be submitted by a member of the group. This form can also be submitted online through the Election Management System, available at [www.ecq.qld.gov.au](http://www.ecq.qld.gov.au).

Unless otherwise indicated, all information in this form will be published for public inspection on the ECQ's website.

## Lodgement timeframe

Groups can register at any time up to the close of nominations for an election.
