

## Nomination for the Legislative Assembly

#### For candidates NOT endorsed by a registered political party

If you are nominating to be elected to sit in the Queensland Legislative Assembly you must:

- be enrolled on the electoral roll for the State of Queensland;
- an Australian citizen
- not a disqualified person under Subsection (2) or (3) of Section 64 of the *Parliament of Queensland Act* 2001.

It is the responsibility of the candidate to ensure that they are eligible for nomination.

A person must be **nominated by six** (6) or more persons on the Queensland electoral roll for the electoral district the candidate is nominating for (Part G & H). None of the nominating persons can have nominated another candidate for this election.

The nominated candidate is required to **deposit \$250** with the ECQ or Returning Officer of the electoral district they are being nominated in at the time of nomination. Cash, bank cheque, credit card and EFT payment is accepted.

Under the *Electoral Act 1992*, candidates must maintain a dedicated State campaign bank account. Bank account details must be provided to the ECQ **within 5 days**. The nomination deposit will be refunded to this account after the election, if applicable.

#### Lodgement timeframe

A nomination will only be accepted from **the day after** the issue of the writ for the election.

Completed nomination forms and nomination deposits must be lodged with the ECQ before noon on the cut-off day for nominations.
