The Local Government Electoral Act 2011 allows candidates to form a group to contest an election. Groups must be registered before candidates can engage in group campaign activities. This form should be completed to apply to the ECQ to register a group, and must be submitted by a member of the group. This form can also be submitted online through the Election Management System, available at www.ecq.qld.gov.au.

Unless otherwise indicated, all information in this form will be published for public inspection on the ECQ's website.

Groups can register at any time up to the close of nominations for an election.
