

# Electoral Commission of Queensland Disclosure Return – Donor to Registered Political Party

The *Electoral Act 1992* requires that a person who makes gifts totalling \$1,000 or more to the same registered political party must give the Electoral Commission of Queensland a return in this approved form.

Where a person who is required to disclose a gift, received a gift of \$1,000 or more which was used to make all or a substantial part of the gift to the party, details of the gift received must also be reported in this form.

Returns must be lodged within 8 weeks of the end of each reporting period. A reporting period is: - ♦ the period starting 1 January and ending 30 June - returns due 25 August;  
♦ the period starting 1 July and ending 31 December- returns due 25 February.


