# **Background**

On the 17 August 2018, the Honourable Minister for Local Government, Minister for Racing and Minister for Multicultural Affairs, Stirling Hinchliffe MP, referred an application proposing a realignment of the common boundary between the Toowoomba Regional Council and South Burnett Regional Council.

The application proposes that—

• Lot 155 on FY2699 currently located in the South Burnett Regional Council

be transferred to the Toowoomba Regional Council.

The Change Commission for this review is comprised of the Electoral Commissioner, Mr Pat Vidgen, in accordance with Section 22 of the *Local Government Act 2009* (the Act).

The Change Commission is responsible for assessing whether a proposed local government change is in the public interest. In doing so, the Change Commission must consider—

- whether the proposed local government change is consistent with the Act;
- the views of the Minister about the proposed local government change; and
- any other matters prescribed under a regulation.

Section 19(3) of the Act provides that the Change Commission may conduct its assessment in any way that it considers appropriate including, for example—

- ask for submissions from any local government that would be affected by the proposed local government change; or
- hold a public hearing to ask the public for its views about the proposed local government change.

Given the minor nature of the proposed change, it was determined that a public hearing was unnecessary on this occasion and instead the Change Commission consulted with the single impacted land owner of Lot 155 on FY2699.

#### **Submissions**

The Minister referred this matter to the Change Commission based on a submission received from the Toowoomba Regional Council. The Minister did not express a view for or against the proposal (see Appendix A). The Councils' submissions are included in Appendix B.

The Minister's referral included the Toowoomba Regional Council's submission supporting the transfer of Lot 155 on FY2699 to the Toowoomba Regional Council. The boundary anomaly was initially identified by the Department of Natural Resources, Mines and Energy, as noted in the Toowoomba Regional Council's submission. Minutes from the South Burnett Regional Council's General Meeting on 18 April 2018 were also included and note the recommended minor boundary change was carried unanimously by the Councillors.

Correspondence between the private owner of Lot 155 on FY2699 and the Department of Local Government, Racing and Multicultural Affairs was included in the Toowoomba Regional Council's submission. The land owner indicated 'in principle' support for the proposal (see Appendix B). The Change Commission contacted the land owner of Lot 155 on FY2699 on 9 October 2018 and received a written submission supporting the proposed transfer of the lot to the Toowoomba Regional Council (see Appendix C).

The Change Commission determined it was unnecessary to call for further submissions on this occasion as both of the Councils and the land owner support the proposed change.

# **Findings**

At present the common boundary between the two Councils dissects two lots, both owned by the same person. Section 9 of the *Local Government Regulation 2012* notes the external boundaries of a local government area should have regard for communities of interest and not dissect properties.

By changing the common boundary as proposed, the local government boundary will no longer dissect two lots owned by the impacted land owner. In doing so, the land owner's two lots will be included in a single Council area, helping to reduce the administrative burden of answering to two local governments. It will also create an easily identifiable common boundary by following the New England Highway.

In light of the considerations above and as all parties to this matter are in agreement with the proposed change, the Change Commission finds it to be in the public interest. The proposed boundary change is assessed as being consistent with the Act.

#### Recommendation

After assessing the material submitted and having taken into account all considerations specified in the Act, it is recommended that—

• Lot 155 on FY2699 be transferred from the South Burnett Regional Council to the Toowoomba Regional Council. The lot is located in the locality of Neumgna.

# Implementation

The Governor in Council may implement the Change Commission's recommendation under a regulation.

The regulation may provide for anything that is necessary or convenient to facilitate the implementation of the local government change.

# Re: Local Government Boundary Anomalies - Toowoomba Regional Council and South **Burnett Regional Council**

I seek your consideration to propose to the Local Government Change Commission, a minor change to the local government area boundary shared by Toowoomba Regional Council and South Burnett Regional Council by removing Lot 155 FY2699 from the South Burnett Local Government Area (LGA) and incorporating this lot into the Toowoomba LGA.

The Department of Natural Resources, Mines and Energy has identified a portion of the boundary between Toowoomba and South Burnett LGAs dissects two (2) allotments under the same ownership. Lot 155 FY2699 (3.84 hectares) is currently part of South Burnett Regional Council and Lot 208 CSH1552 (257 hectares) is currently part of Toowoomba Regional Council. These lots are suited to a minor local government boundary change involving the moving of the existing boundary to the centreline of the New England Highway resulting in Lot 155 FY2699 falling within the Toowoomba LGA.

The owner of the two (2) lots has provided 'in principal' support to the boundary change to your Department. South Burnett Regional Council have resolved to offer no objection to the minor boundary change (copy of resolution attached) and Toowoomba Regional Council have also resolved to make this change (copy of resolution attached).

This proposed minor boundary change is not a significant change for either Council but will assist the owner of the land with having to deal with only one (1) Council for rate payments and other Council business. It is expected that the ratepayer will also benefit by saving approximately \$700 per annum in rate payments.

#### PURPOSE OF REPORT

To seek Council endorsement of a proposal to alter the local government area boundary between South Burnett Regional Council and Toowoomba Regional Council, in the Upper Yarraman locality.

# **EXECUTIVE SUMMARY**

A portion of the boundary between South Burnett and Toowoomba Local Government Areas (LGAs) dissect two (2) lots under the same ownership with Lot 155 FY2699 part of South Burnett Regional Council and Lot 208 CSH1552 part of Toowoomba Regional Council.

The Department of Natural Resources, Mines and Energy (DNRME) has identified the lots as suited to a minor local government boundary change. Council's view on a boundary change by way of movement of the boundary to the centreline of the New England Highway, which is a logical boundary alignment, is requested.

The owner of the two (2) allotments has been contacted by the Department of Local Government, Racing and Multicultural Affairs (DLGRMA) and given support for the boundary change and to have both allotments within Toowoomba Regional Council boundaries. South Burnett Regional Council has also advised DLGRMA that this matter has been considered and confirmed that it has no objection to the proposed minor boundary change.

#### RECOMMENDATION

That the Minister for Local Government, Racing and Multicultural Affairs be requested to propose a minor change to the local government area boundary shared by Toowoomba Regional Council and South Burnett Regional Council to the Change Commission by removing Lot 155 FY2699 from the South Burnett Local Government Area and incorporating this lot into the Toowoomba Local Government Area.

#### REASONS FOR RECOMMENDATION

The proposed minor boundary change will be of benefit to the current owner of Lots 155 FY2699 and 208 CSH1552, have negligible impact on both South Burnett and Toowoomba Regional Councils, and will follow the New England Highway centreline alignment rather than dissecting a rural allotment.

# **COMMITTEE RECOMMENDATION**

That the Minister for Local Government, Racing and Multicultural Affairs be requested to propose a minor change to the local government area boundary shared by Toowoomba Regional Council and South Burnett Regional Council to the Change Commission by removing Lot 155 FY2699 from the South Burnett Local Government Area and incorporating this lot into the Toowoomba Local Government Area.

#### BACKGROUND

A portion of the boundary between South Burnett and Toowoomba Local Government Areas (LGAs) dissect two (2) lots under the same ownership with Lot 155 FY2699 part of South Burnett Regional Council and Lot 208 CSH1552 part of the Toowoomba Regional Council.

DNRME has identified the lots as suited to a minor local government boundary change. This change involves moving the existing boundary to the centreline of the New England Highway resulting in Lot 155 FY2699 falling within the Toowoomba LGA. Refer to **Attachment 1** - map of the proposed minor boundary change.

Lot 155 FY2699 is approximately 3.84 hectares in size and Lot 208 CSH1552 is approximately 257 hectares in size. Lot 208 CSH1552 is rated in our Medium Intensity Rural rating category and should Lot 155 FY2699 be added, it will either have no impact or minimal impact on the level of rates and charges.

This proposed minor boundary change is not a significant change for either Council, but will assist the owner of the land with having to deal with only one (1) Council for rate payments and other Council business.

#### ISSUES, RISKS AND RESPONSES

The owner of the two (2) allotments has been contacted by the DLGRMA and given support for the boundary change and to have both allotments within Toowoomba Regional Council boundaries. South Burnett Regional Council has also advised DLGRMA that this matter has been considered and confirmed that it has have no objection to the proposed minor boundary change.

Under Sections 18 and 19 of the *Local Government Act 2009* only the Minister may propose a local government change to the Change Commission. The Change Commission is responsible for assessing whether a local government change proposed by the Minister is in the public interest. Toowoomba Regional Council will be required to submit to the Minister a request to seek a boundary change for this proposal to be considered by the Change Commission.

A consequential issue arising from this boundary change is the need to amend the Toowoomba Regional Planning Scheme to include this particular area in the planning scheme. Any amendment to the Planning Scheme will reflect and be consistent with the zones of adjoining properties.

#### FINANCIAL / RESOURCE IMPLICATIONS

The proposed change to the boundary is not expected to have any financial or resource implications. The proposed change would result in an immaterial change to rates and charges income.

# CONCLUSION

The proposed minor boundary change would be of benefit to the ratepayer having only to deal with one (1) Council rather than the current arrangement of dealing with both South Burnett and Toowoomba Regional Councils. Both the ratepayer and South Burnett Regional Council have indicated their support for this proposal.

On the 21 August 2018, I received a referral from the Minister for Local Government requesting the Change Commission assess a proposed change to the boundary between the Toowoomba Regional Council (TRC) and South Burnett Regional Council (SBRC). 
