

Application to change group membership

If a group has been previously registered for an election, the *Local Government Electoral Act 2011* allows a group's agent to change the membership of that group.

Groups can only have one mayoral candidate, and can only contest one local government area. Candidates cannot be a part of a group if they are a member of another group, or if the candidate is endorsed by a registered political party. Changes to a group's membership must not result in only one candidate being part of a group. Applications which do not meet these requirements cannot be accepted.

A group's agent may complete this form to change a group's membership. This form can also be completed online through the Self Service Portal, available at www.ecq.qld.gov.au.

Forms submitted by someone other than the registered agent of the group cannot be accepted.

Unless otherwise indicated, all information in this form will be published for public inspection on the ECQ's website.

Lodgement timeframe

A group's agent can change the group's membership at any time up to the day before polling day for an election. Candidates must not conduct group campaign activities until the change in the group is registered.

Applications which are received after the close of nominations for an election will not be reflected on the ballot paper for the election.
