Nominations open at midday on Monday, 3 June 2019. Nominations must be in writing, comply with the rules of the Association, and **be received by the Electoral Commission of Queensland (the ECQ) no later than midday on Monday, 1 July 2019.**

Candidate Notes

Candidates for election must be a financial member of the Union thirty (30) days before nominations open. Candidates for the positions of **President**, **Vice President**, or **Treasurer** must have served two (2) years on the Council immediately previous to their nomination. A person may nominate for more than one office.

Nominations must be received in writing and include the signature of the nominee. Nominees should ensure that their nomination is received by the ECQ and can be clearly read. A nomination form is included with this notice. Additional forms can be obtained from the Organisation or the ECQ.

Ballot

Should a ballot be necessary, the ECQ will conduct a secret postal ballot of eligible members. The ballot will open on Friday, 2 August 2019 and close at midday on Friday, 23 August 2019.

The roll of voters will be prepared following the close of nominations. To be eligible to vote a member must be a financial member of the Union thirty (30) days before opening of nominations.

Ballots are decided by the first-past-the-post system of voting.
