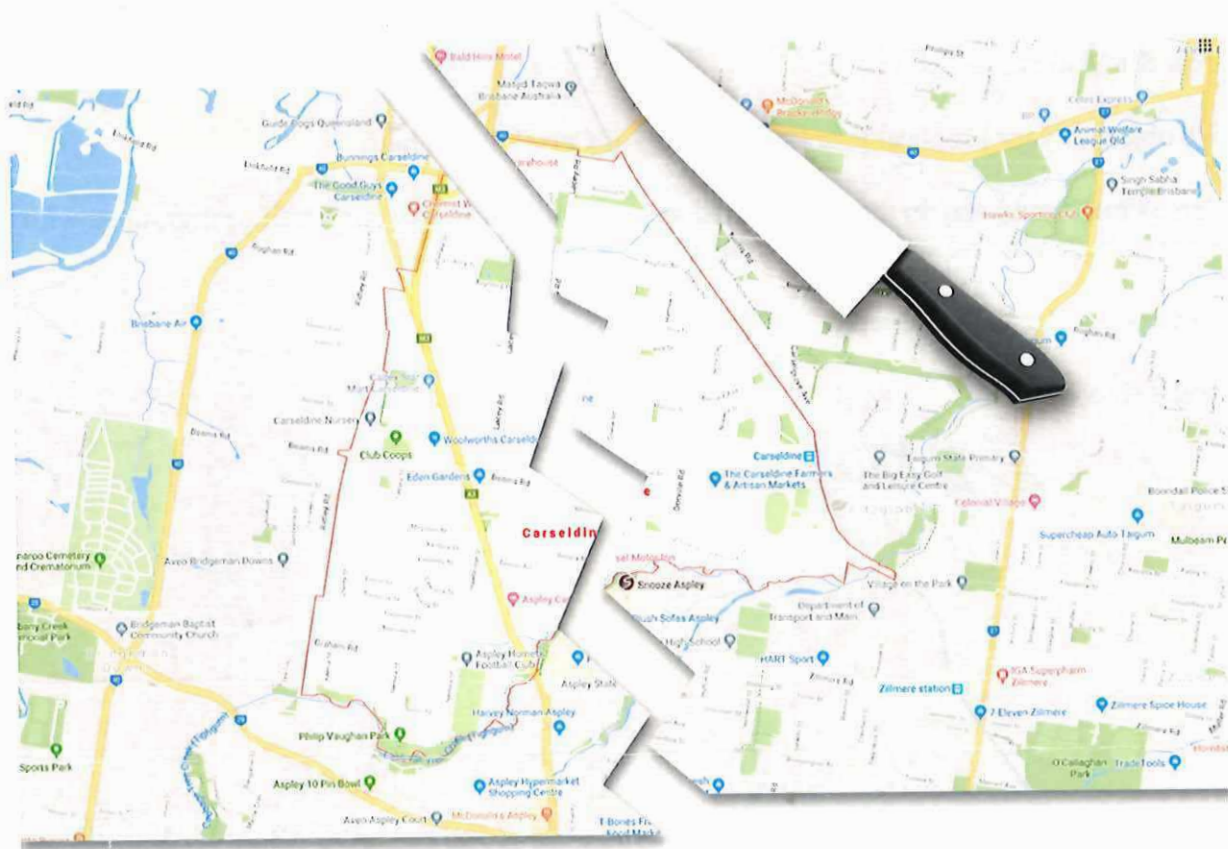


# DON'T CUT UP CARSELDINE
