### Nominations

Nominations open at midday on Tuesday, 24 February 2026. All nominations must **reach the Electoral Commission of Queensland (ECQ) no later than midday on Tuesday, 24 March 2026**. A nomination form is printed with this notice. Additional forms can be obtained either from the Union, the office of the ECQ or on the ECQ's website; [www.ecq.qld.gov.au](http://www.ecq.qld.gov.au).

To be eligible to nominate, candidates must be a financial member of the Union thirty (30) days prior to the opening of nominations, who is not a Professional Engineer, Pharmacist or a Professional Scientist member.

Nominations may be received by hand delivery, post or email and must include the signature of the nominee. Nominees should ensure that their nomination is received by the ECQ and can be clearly read.

### Ballot

If necessary, the ECQ will undertake a postal ballot of eligible members commencing **Tuesday, 14 April 2026** and closing at **midday on Friday, 15 May 2026**. To be eligible to vote, members must be a financial member thirty (30) days before the date nominations open.

The position is to be elected by eligible members of the Union. Members should advise the Union of any change relating to their membership details.

Ballots are decided by a first-past-the-post system of voting.
