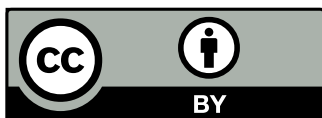

Foreword

The Electoral Commission of Queensland (ECQ) is pleased to present its first aggregated report on local government by-elections, covering by-elections conducted between the 2020 and 2024 local government quadrennial elections.

While much public attention is focused on the major State and local government elections held every four years, the delivery of local government by-elections is an important service delivered by the ECQ to ensure continuity of public administration for Queenslanders. As highlighted in this report, the delivery of 30 local government by-elections over a three-year period entails a significant body of work for the ECQ between major election events.

Across Queensland, there are 77 local governments, constituted by 77 mayors and 501 elected councillors. Over a four-year term, vacancies invariably arise, most of which must be filled through a by-election in accordance with the *Local Government Act 2009* and *Local Government Electoral Act 2011*. Since the 2020 local government elections, the ECQ has remained in a state of election-readiness and has filled 33 vacant positions either through by-elections or by notice.

Each by-election is a resource-intensive exercise. From the public's perspective, the planning and delivery of each by-election occurs seamlessly and with minimal disruption. However, the ECQ invests significant effort to achieve this.

The ECQ has increased its collaboration with local governments in the planning, delivery, and evaluation of elections, including by-elections, with the aim of improving service delivery to Queensland electors and their local governments. I thank our local government partners for their support and cooperation in these endeavours.

The ECQ strives to continually improve the services provided to Queenslanders, and local government by-election delivery presents opportunities to trial innovations and test the ongoing stability and effectiveness of processes and systems.

Over the previous local government term, the ECQ has refined its election budget estimate process, tested measures to reduce the number of rejected postal votes and trialled new methods to communicate with electors. These innovations will be assessed and evaluated to determine if they can be applied widely and improve electoral services for all Queenslanders.

Additionally, the ECQ ensures the ongoing integrity of the electoral process during by-elections by supporting, monitoring, and enforcing candidate compliance with funding and disclosure obligations.

I hope this report contributes to enhanced understanding of the delivery of local government by-elections in Queensland. These activities would not be possible without our people, and I would like to acknowledge and thank the staff of the ECQ and our many Returning Officers and other temporary election staff for continuing to deliver excellent electoral services for all Queenslanders.

Introduction

The Electoral Commission of Queensland (ECQ) is an independent statutory body established under the *Electoral Act 1992* and is responsible for the impartial conduct of Queensland state, local government and industrial elections. These functions extend to the conduct of by-elections for vacancies that arise in local government offices of councillor or mayor during their term.

Vacancies in local government offices arise for various reasons, including resignation or election to higher office. Under the *Local Government Act 2009*, these vacancies must be filled within two months of the vacancy arising¹. The ECQ fills these vacancies according to the requirements set out in the *Local Government Act* and the *Local Government Electoral Act 2011*.

The following report provides a brief overview of the voting information and results for all local government by-elections the ECQ has delivered from the local government quadrennial elections on 28 March 2020 until 15 April 2023. Detailed results information for each by-election can be found at www.ecq.qld.gov.au/elections/election-events.

Term of local government and local government vacancies

Under the *Local Government Act*, the term of local government is separated into three different time periods:

- ▶ the beginning of the term, which is the first 12 months following the quadrennial elections
- ▶ the middle of the term, which is the subsequent 24 months, and
- ▶ the final part of the term, which is last 12 months prior to the next quadrennial elections.

How a vacancy in local government is filled is dependent on when a vacancy arises, and if it is in the office of mayor or councillor². If the office of mayor becomes vacant during the beginning or middle of the local government's term it must be filled through a by-election. Vacancies arising in the office of mayor during the final part of the local government's term must be filled by appointing another councillor to the office.

Alternatively, if the office of a councillor becomes vacant in the beginning of the term, the local government can opt to hold a by-election or request the ECQ issue a vacancy notice to the 'runner-up' at the last quadrennial elections seeking their permission to appoint them to fill the vacancy. Vacancies arising in the office of a councillor during the middle of the term must be filled through a by-election. Finally, if the vacancy arises in the final part of the term, the council must appoint an eligible person according to the requirements set out in section 166B of the *Local Government Act*.

Vacancies filled

For the reporting period, the ECQ conducted 30 by-elections to fill 31 vacant positions in local governments across Queensland as listed in the following table³.

¹ Section 163 of the *Local Government Act* states that if a councillor's office, other than a mayor's office, becomes vacant three months or more before quadrennial elections are required to be held, the local government must fill the vacant office. A mayor's office must be filled if it becomes vacant at any time before the quadrennial elections. The local government must fill these vacant offices within two months after the office becomes vacant.

² Chapter 6, Part 2, Division 3 of the *Local Government Act* outlines how vacancies are to be filled.

³ One by-election was held to fill two vacancies for Diamantina Shire Council on 5 November 2022.

In addition to the vacancies filled through by-elections, the ECQ also issued vacancy notices in both Livingstone Shire Council and Diamantina Shire Council in accordance with section 166A of the *Local Government Act*.

In both instances the runners-up consented and were appointed by the council to the office of councillor. The table below provides details on the filling of these vacancies.

Full postal elections

Most of the by-elections conducted by the ECQ during the reporting period were attendance ballots, meaning in-person voting services at early voting centres or election day polling booths were provided to all electors, with postal voting services also available to those who applied.

However, full postal ballots may be conducted if the Minister responsible for Local Government (the Minister) approves a council's request to run such an election. In these elections, all electors are automatically sent a postal ballot, and no in-person voting services are made available.

Section 45AA of the *Local Government Electoral Act 2011* states that a local government may apply to the Minister for a by-election to be

conducted as a full postal ballot. The Minister must refer the application to the Electoral Commissioner to provide a recommendation on which the Minister can decide whether to approve or not approve the application.

For the reporting period, six local government by-elections, for the Barcoo Shire Council, North Burnett Regional Council (Mayor), Richmond Shire Council, North Burnett Regional Council (Division 2 councillor), Diamantina Shire Council and Longreach Regional Council were conducted as full postal ballots. The Balonne Shire Council by-election in October 2022 was also approved to be a full postal ballot, however, voting was not required as only one person nominated, automatically making them the successful candidate.

By-election voter turnout

The turnout for by-elections generally declines compared to the rates at quadrennial elections. Across the by-elections held over this period, there was an average decrease in turnout of 12.17 percentage points compared to the equivalent turnout at the 2020 local government

elections⁴. The table below presents the elections where such comparisons are possible. The largest decrease of 33.31 percentage points was observed in the Napranum Aboriginal Shire Council by-election and conversely, a 3.84 percentage point increase was observed in the Rockhampton Mayoral by-election.

By-election informality rate

Across the by-elections held over this period, there was an average decrease in informal voting of 1.05 percentage points compared to the equivalent informal voting rate at the 2020 local government elections⁵. However, this relatively small change in informality can mask significant variation between councils.

The table below, which presents the informality data, shows a decrease of 12.10 percentage points in the Aurukun Shire Council by-election and conversely, a 7.25 percentage point increase in the North Burnett Regional Council by-election.

It is noted that councillor by-elections in undivided councils do not present an exact comparison with the 2020 local government

elections, as typically only one vacancy is filled at a by-election compared to all councillor positions at a quadrennial election. In its analysis of informality at the 2020 local government elections, the ECQ noted the requirement to vote for a specific number of candidates may have contributed to a high level of unintentional informality in certain undivided councils, including Aurukun. This analysis can be viewed in the [2020 local government elections report](#).

The causes for these changes are complex and multifaceted. Informality is impacted by the voting system in use at an election, such as first-past-the-post or optional preferential voting, and the lower participation rates observed at by-elections as more engaged voters will attend a by-election and cast a formal ballot.

Indigenous local governments

The ECQ conducted by-elections in six Indigenous local governments in the reporting period. These vacancies occurred in the office of councillor in the Aurukun Shire Council, Mapoon Aboriginal Shire Council (August 2021 and March 2023), Torres Strait Island Regional Council (Division 14), Northern Peninsula Area Regional Council (Division 5), Yarrabah Aboriginal Shire Council and Woorabinda Aboriginal Shire Council.

Each of these by-elections were conducted as an attendance ballot excluding the two by-elections for Mapoon Aboriginal Shire Council which were uncontested, meaning only one person nominated for election, automatically making them the successful candidate.

Overview of by-elections

The following sections provide a summary of each by-election undertaken by the ECQ between the local government quadrennial elections in March 2020 and the conclusion of the by-election period in April 2023.

Information provided includes the reasons for the vacancy arising, the timetable, enrolment data, electoral service usage, and results. By-elections are presented in chronological order, followed by details of uncontested elections. Full results are available on the ECQ website at www.ecq.qld.gov.au.

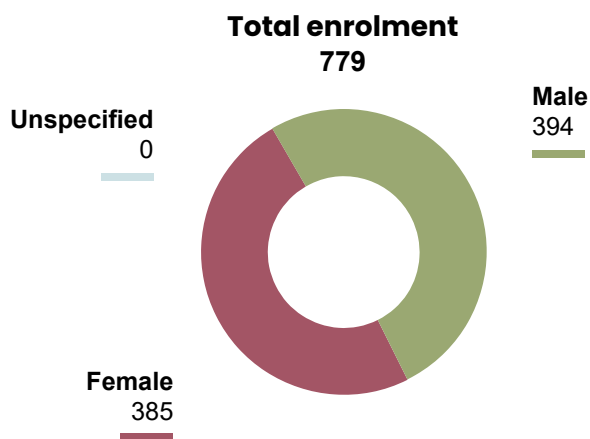
