### Nominations

#### Nominations close at midday on Thursday, 8 May 2025

Nominations open at midday on Thursday, 3 April 2025 and close at midday on Thursday, 8 May 2025. All nominations must be received by the Electoral Commission of Queensland (ECQ) no later than midday on Thursday, 8 May 2025. A nomination form is included with this notice. Additional forms can be obtained from the Union or the ECQ's website; [www.ecq.qld.gov.au](http://www.ecq.qld.gov.au).

Candidates for election must be financial members of the Queensland Fire and Rescue - Senior Officers Union of Employees 30 days prior to the opening of nominations. Candidates for Branch Councillor must be a financial member within the specified branch.

Nominations must be in writing, signed by the nominee, and may be lodged by either hand delivery, post or email.

### Ballot

If necessary, the ECQ will conduct a secret postal ballot of eligible members. The ballot will open on Wednesday, 28 May 2025 and close at midday on Wednesday, 25 June 2025.

Only members that are financial 30 days before nominations open are eligible to vote in the election. Each member is responsible for ensuring that the Union has their correct details recorded. A roll of voters is prepared from those records when nominations close.

The successful candidate will be elected by the first-past-the-post voting system set out in the Union's rules.
