- The projected enrolments in 2024 of 135,928 is an increase of 6.18% over the January 2019 enrolment figure of 127,521. This projected growth is unrealistic given total enrolments only grew 1.9% between March 2016 (125,147) and January 2019 (127,521).
- Enrolments as at September 2019 have dropped to 127,453. This drop could largely be attributed to the effects of the unprecedented weather event that impacted parts of the city in early 2019.
- Table 3 shows the suburb locations of the SA1s with significant anticipated growth.

- The figures reflect the rapid growth currently being experienced in Division 2.
 However, the anticipated development in the suburbs of Idalia and Oonoonba in Division 10 is likely to slow dramatically given that these suburbs suffered extensive damage during the flood.
- Moving the Division 10 boundary to accommodate this anticipated growth is likely to result in the division being very close to the bottom of the quota by 2024.



As a resident of Division 10 I am concerned with the proposed changes. The proposed boundary change will see Railway Estate moved into Division 9.

The voters in Division 9, live on the other side of the rail line near Hermit Park which has no community of interest with the southern part of the Division 10. Our community of interest lies with the southern suburbs along the coast. I request no boundary changes at this stage as Railway Estate and Fairfield Waters are still recovering from the devastating Monsoon Event in February this year (2019) and a large percentage of voters have moved out. I feel Division 10 has not reached the required threshold to trigger a redistribution.
