Nominations

Nominations open on Tuesday, 12 August 2025. All nominations must be in writing and signed by the nominee and two (2) nominators and **reach the Electoral Commission of Queensland (ECQ) no later than midday on Tuesday, 2 September 2025.**

To be eligible to nominate, candidates must be financial members of the Union and for the positions of Vice President and State Management Committee Members belong to the relevant Industry Group.

Nominations may be received by hand delivery, post or email. Nominees should ensure that their nomination is received by the ECQ and can be clearly read.

Ballot

If necessary, the ECQ will conduct a secret postal ballot of eligible members commencing **Friday, 12 September 2025** and closing at **midday on Tuesday, 7 October 2025**. To be eligible to vote, members must be a financial member thirty (30) days before the date nominations open. Ballots are decided by a first-past-the-post system of voting.
