LIVINGSTONE & ROCKHAMPTON BOUNDARY REVIEW

The Minister responsible for Local Government has asked the Local Government Change Commission (Change Commission) to assess a proposal to transfer the Glendale, Glenlee and Rockyview suburbs from Livingstone Shire Council to Rockhampton Regional Council.

A voluntary survey is open from 20 June to 5pm 4 July 2022. Respond by answering:

- 'Yes' if you support transferring the suburbs to Rockhampton Regional Council, OR
- 'No' if you support the suburbs remaining in Livingstone Shire Council.

Background

In 2008, Livingstone Shire and the surrounding councils were merged to form Rockhampton Regional Council (RRC).

In 2013, a de-amalgamation poll asked electors from the former Livingstone Shire whether a Livingstone Shire Council (LSC) should be created (with costs of any change to be met by LSC). Participants returned a 56.59 per cent 'yes' response¹ and in 2014 the LSC was established.

Since this time, the RRC and purportedly many Glenlee, Glendale and Rockyview residents, have formed the view that these suburbs should be part of the RRC.

The LSC opposes this proposed change.

Local Government Change Commission

The Change Commission is established under the *Local Government Act 2009* to assess if proposed local government changes are in the public interest.

For this review, the Change Commission includes:

- Pat Vidgen, Electoral Commissioner,
- Wade Lewis, Casual Commissioner,
- Peter McGraw, Casual Commissioner.

The Change Commission is supported administratively by Electoral Commission of Queensland (ECQ) staff.

Financial assessment

The Queensland Treasury Corporation (QTC) has assessed the viability of the proposed change, working with both councils to estimate the financial impacts.

Public consultation

People on the electoral roll in LSC and RRC at the end of May 2022 have received this mailout and survey.

Participation in the survey is voluntary and the results are non-binding.

In addition to the survey, any interested persons can lodge a written submission up until 5pm Monday, 4 July 2022.

Written submissions can be made through the online form on the ECQ website, by email or by post.

Results of public consultation

Participation in, and results from the survey, as well as feedback from written submissions will form an important part of the Change Commission's assessment.

Survey results and written submissions will be published on the ECQ website in early August 2022.

Message from Rockhampton Regional Council - Statement in favour of change

We need you to vote YES to secure our futures. This is your chance to support the transfer of Glendale, Glenlee and Rockyview back to the Rockhampton Region and your YES vote will define the Rockhampton Region and Livingstone Shire for decades to come.

Rockhampton is running out of room to build our future and the Northern Suburbs is where our population will grow. Our growth is constrained to the East by the Berserker Range and to the West and South by floodplain. **The North represents another 50 years of growth for the Rockhampton Region**. Financial considerations

The Queensland Treasury Corporation (QTC) has prepared a report on the financial impacts of the proposed boundary change*. The report found the change may result in:

- A marginal positive impact on RRC's financial profile.
- An expected increase in RRC's total revenue by \$36 million from 2024-25 to 2030-31.
- An increase in RRC's ratepayer base by 3.4% in 2024-25.
- An increase in RRC's property, plant and equipment by 1.3% in 2024-25.
- An increase in net operating results for RRC of \$5.7 million over the forecast 2024-25 to 2030-31 period. If the full financial impact is passed on to residents, this positive impact would potentially equate to a \$36 decrease in average rates and charges per rateable property in 2024-25, though this is forecast to decrease to \$14 per rateable property by 2030-31.
- Based on RRC estimates at the time of the financial review, an average rates and utilities bill
 for Glenlee, Glendale and Rockyview of \$4,627 in 2024–25, compared to LSC's forecast rates
 and utility charges of \$5,300 for that year (\$673 less per property).

Message from Livingstone Shire Council - Statement opposing the change

Removal of the northern suburbs of Glenlee, Glendale and Rockyview will have diabolical financial impacts to our way of life and prosperity. It creates a **strong precedent** for further 'attempts' not only to our shire but other Local Governments across the State. The proud Shire of Livingstone was established in 1903. Glenlee, Glendale and Rockyview have never **belonged to Rockhampton!**

The Queensland Government's financial analysis clearly states that our property rates will need to increase **between \$161 and \$250 annually** to fund the boundary change alone! Our ratepayers are **already burdened** by some of the highest rates in Queensland due to the unfair financial impacts imposed at de-amalgamation in 2014. The Rockhampton Mayor says a boundary change is fairer for all. It's not. It only advantages Rockhampton. Financial considerations

The Queensland Treasury Corporation (QTC) has prepared a report on the financial impacts of the proposed boundary change*. The report found the change may result in:

- A negative impact on LSC's financial profile.
- An expected decrease in LSC's total revenue by \$59 million from 2024-25 to 2030-31.
- A decrease in LSC's ratepayer base by 6.7% in 2024-25.
- A decrease in LSC's property, plant and equipment by 3.7% in 2024-25.
- A decrease in net operating results for LSC of \$26.4 million over the forecast 2024-25 to 2030-31 period. If the full financial impact is passed on to residents, this negative impact would potentially equate to a \$161 increase in the average rates and charges per rateable property in 2024-25 and this is forecast to increase to \$250 per rateable property by 2030-31.
