Nominations

Nominations close at midday on Friday, 9 April 2021

Nominations open at midday on Tuesday, 9 March 2021. All nominations must **reach the Electoral Commission of Queensland (ECQ) no later than midday on Friday, 9 April 2021**. A nomination form is included with this notice. Additional forms can be obtained from the Union, the office of the ECQ and on the ECQ's web site; www.ecq.qld.gov.au.

To be eligible to nominate, candidates must be a financial member of the Union thirty (30) days prior to the opening of nominations and must be a member of the Mining, Energy and Ports Division State Committee of Management. Candidates must be nominated, and have that nomination seconded, by a member of the Mining, Energy and Ports Division State Committee of Management.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominee and nominators. Nominees should ensure that their nomination is received by the ECQ and can be clearly read.

Ballot

If necessary, the ECQ will conduct a secret ballot of eligible members at the meeting of the Management Committee of the Mining, Energy and Ports Division. To be eligible to vote members must be a financial member thirty (30) days before nominations open.

The position is to be elected by eligible members of the Mining, Energy and Ports Division State Committee of Management. Members should advise the Union of any change to their membership details.

Ballots are decided by a first-past-the-post system of voting.
