The Queensland Industrial Registrar has issued a Decision pursuant to the *Industrial Relations Act 2016* that the Electoral Commission of Queensland (ECQ) conduct an election for The Registered and Licensed Clubs Association of Queensland, Union of Employers. Nominations

Nominations open at midday on Wednesday, 11 October 2023. **Nominations must reach the ECQ by midday on Thursday, 2 November 2023.** A nomination form is included with this notice, additional forms can be obtained from the Union, the office of the ECQ or the ECQ's website; www.ecq.qld.gov.au.

Candidates for election for the position of **President** must have served at least one year on the Board of the Association within the previous three years or serve on the committee or Board of a Member club.

Candidates for election for the position of **Region Director** must have served at least one year on the Board of the Association within the previous three years or serve on a committee or Board of a Member club or be gainfully employed as a Club Manager, General Manager or Chief Executive Officer of a Member club.

Nominations must be signed by both the nominee and an authorised officer of the nominating club. Nominations may be lodged by hand, post or email. Nominees should confirm their nomination is received and can be clearly read.

Candidate Statement

Candidates may lodge a statement expressing their views to the Union's members. Statements must reach the ECQ by the close of nominations. Statements will be distributed with voting materials.

Ballot

If necessary the ECQ will conduct a postal ballot of eligible Member clubs. Only clubs that are financial 30 days before nominations open are eligible to vote. The successful candidate will be elected by the direct multiple voting system set out in the Union's rules. Each Member club is responsible for ensuring that the Union has their correct details recorded. A roll of voters is prepared from those records when nominations close.

The ballot will **open on Monday, 20 November 2023** and **close at midday on Wednesday, 20 December 2023.**
