Candidate Notes

Nominations open at midday on Wednesday, 15 April 2020. Nominations must be in writing, comply with the rules of the Union, and **be received by the Electoral Commission of Queensland (ECQ) no later than midday on Wednesday, 13 May 2020.**

Candidates for election must be eligible executive members of the Union assigned to or stationed at a police establishment not more than 240km by road from the General Post Office in Brisbane. Candidates should verify their financial status and other qualifications required by the Union's rules before lodging a nomination form with the ECQ.

Nominations close at midday on Wednesday, 13 May 2020

Nominations may be received by hand delivery, post, fax, or email and must include the signature of the nominee. Nominees should ensure that their nomination is received by the ECQ and can be clearly read. A nomination form is included with this notice. Additional forms can be obtained from the Union or the ECQ's website; www.ecq.qld.gov.au.

Candidates wishing to withdraw their nomination may do so by written notice to the ECQ no later than seven (7) days after nominations close.

Ballot

Should a ballot be necessary, the ECQ will conduct a secret postal ballot of eligible members. The ballot will **open on Thursday, 28 May 2020 and close at midday on Thursday, 25 June 2020.**

The roll of voters will be prepared following the close of nominations, To be eligible to vote a member must be a financial member of the Union thirty (30) days before nominations open.
