Candidate Notes

Candidates for election must be financial members of the Union at the close of nominations. All nominations must be in writing and signed by the nominee and at least two (2) financial member of the Union, provided that:

Nominees for the position of State Council Representative of a Branch must be a member of the respective Branch and signed by at least two (2) financial members of the respective Branch.

Candidates for the position of Member of Executive must be a Branch or Area Council Council Representative or be a duly nominated candidate for election as a Branch or Area Council Council Representative.

Candidates who wish to withdraw their nomination may do so not more than five (5) clear days after the close of nominations. Candidates and their nominators can verify (with the Union) their financial status and other qualifications required (refer to Union Rules 6.4 & 6.5).

Nominations close at midday on Monday, 29 September 2025

Nominations open on **Friday, 5 September 2025** and must be in writing, comply with the registered rules of the Union and **reach the Electoral Commission of Queensland (ECQ) no later than midday on Monday, 29 September 2025.** A nomination form for this election is printed with this Journal. Forms are also available from the Union and the ECQ's website; **www.ecq.qld.gov.au**.

Nominations may be received by hand delivey, post or email and must include the signature of the nominees and nominators. Please ensure that your nomination can be clearly read and your email address has been provided.

Ballots

Should a ballot be necessary to declare the State Council Representative position the ECQ will conduct a secret postal ballot that will open on **Monday**, **13 October 2025** and close at midday on **Thursday**, **13 November 2025**.

Should a ballot be necessary to declare the Member of Executive position the ECQ will conduct a secret ballot at the relevant meeting after nominations close.
